After the meeting had been duly called to order, the Chair announced that among the purposes of the meeting was to consider and take action pertaining to the waiver of \$5,118.20 in PILOT Payment late penalties to be paid by Ace Natural, Inc. provided certain local recruitment and retention efforts are met.

RESOLUTION OF THE CITY OF MOUNT VERNON INDUSTRIAL DEVELOPMENT AGENCY APPROVING AND AUTHORIZING THE WAIVER OF \$5,118.20 IN PILOT PAYMENT LATE PENALTIES TO BE PAID BY ACE NATURAL, INC. PROVIDED CERTAIN LOCAL RECRUITMENT AND RETENTION EFFORTS ARE MET.

WHEREAS, by Title I of Article 18-A of the General Municipal Law of the State of New York, as amended, and Chapter 786 of the Laws of 1976 of the State of New York, as the same may be amended from time to time (collectively, the "Act"), the CITY OF MOUNT VERNON INDUSTRIAL DEVELOPMENT AGENCY (the "Agency"), was created with the authority and power among other things, to assist with the acquisition of certain industrial development projects as authorized by the Act; and

WHEREAS, the Act authorizes the Agency (1) to promote the economic welfare, recreational opportunities and prosperity of the inhabitants of the City of Mount Vernon, and (2) to promote, attract, encourage and develop recreation and economically sound commerce and industry through governmental action for the purpose of preventing unemployment and economic deterioration; and

WHEREAS, in 2018, Ace Natural, Inc. ("Company"), requested "financial assistance" (as such term is defined in the Act) of the Agency with respect to a certain project (the "Project") consisting of the renovation and equipping of an existing property (the "Facility Realty") located at 249-257 East Sandford Boulevard, Mount Vernon, New York, owned at that time by Exit 8 Hutch LLC ("Exit 8") and now owned by The Vierling Family, LLC ("Vierling") and leased by Exit 8 (and now Vierling) to the Company, for use as an organic food distribution center, including offices, distribution facilities, and some food processing, packaging and cold storage (collectively, the "Improvements", and together with Facility Realty, the "Project Facility"); and

WHEREAS, among the financial assistance provided to the Company was a partial real property abatement, memorialized in a certain Payment in Lieu of Taxes Agreement, dated as of April 30, 2018, by and between the Exit 8 (now Vierling) and the Agency (the "PILOT Agreement"); and

WHEREAS, the PILOT Agreement assesses certain late fees and penalties in the event PILOT payments are not timely made; and

WHEREAS, as a result of COVID-19 pandemic related difficulties, the Company was tardy in remitting the second half of its 2021 PILOT payment obligation; and

WHEREAS, the Company has petitioned the Agency for relief from the late payment, which is \$6,118.20; and

WHEREAS, the Company has exceeded its hiring requirements, with the exception of the goal of employing 30% of its Project Facility workforce from among City of Mount Vernon residents; and

WHEREAS, the Company has expressed its willingness to collaborate with the Agency to increase its recruitment and retention of Mount Vernon residents to work at the Project Facility; and

WHEREAS, the Agency shall waive \$5,118.20 of the late fees so long as the Company, for the balance of 2022, employs good faith, best efforts to collaborate with the Agency's Business Development Director in improving the recruitment and retention of Mount Vernon residents as employees at the Project Facility (the "Waiver"); and

NOW, THEREFORE, BE IT RESOLVED by the Agency (a majority of the members thereof affirmatively concurring) as follows:

<u>Section 1.</u> The Agency hereby approves and authorizes the Waiver under the terms set forth in the Recitals.

<u>Section 2.</u> That the Agency and the Company shall report to the Board of Directors of their efforts at the January 2023 Board of Directors meeting.

Section 3. The officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required and to execute and deliver all such certificates, instruments and documents as may be necessary or, in the opinion of the officer, employee or agent acting, desirable and proper to effect the purposes of the foregoing resolutions and to cause compliance by the Agency with all of the terms, covenants and provisions of the documents executed for and on behalf of the Agency.

Section 4. This resolution shall take effect immediately.
